

Flora and Fauna Guarantee Act 1988
DECLARED PROTECTED FLORA LIST UPDATE 2024

Order in Council

The Lieutenant-Governor, as the Governor's deputy, with the advice of the Executive Council –

1. under section 46A(1) of the **Flora and Fauna Guarantee Act 1988**, revokes the declarations for the taxa of flora set out in Column 1, and made on the date set out in Column 2, of Table 1 in the Schedule to be protected flora; and
2. under section 46(1) of the **Flora and Fauna Guarantee Act 1988** and section 41A of the **Interpretation of Legislation Act 1984**, amends the declaration of the taxon of flora set out in Column 1, and made on the date set out in Column 2, of Table 2 in the Schedule, to be subject to a restriction on use.

This Order comes into effect on the date it is published in the Government Gazette
